

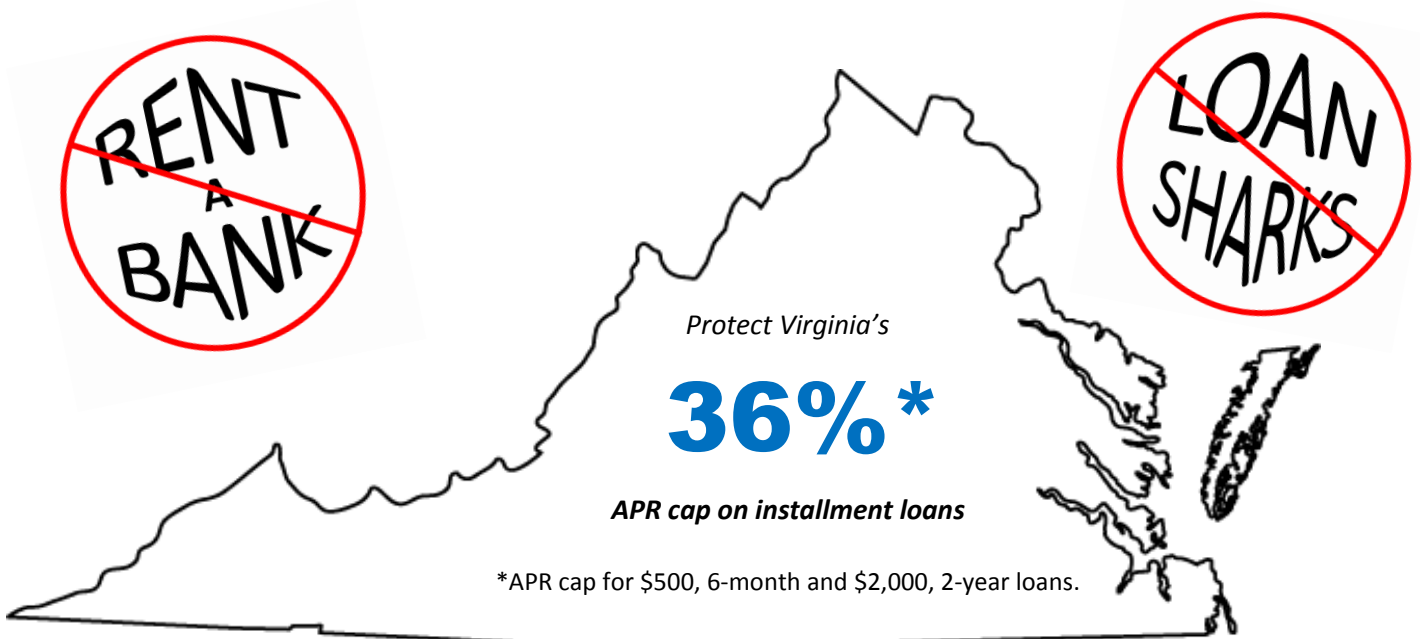


Don't Let **High-Cost Lenders** Get Around
